**Re.: Pedigree Charolais Cattle Sale, November 2025.**

We are proud of the opportunity to offer you our services in conducting the above sale of Pedigree Charolais cattle on **Thursday 6<sup>th</sup> November 2025**.

We enclose herewith entry forms for that sale, and would be obliged if they could be returned to the above address no later than **Thursday 11<sup>th</sup> September**. Please note entry forms must be accompanied with the original pedigree certificates, correct entry fees (£50+VAT bulls and £20+VAT females) and a herd health declaration or entries will not be processed. With reference to the herd health declaration please ensure you have 'ticked' to confirm that cattle entered into the sale are from a CHCS BVD accredited herd, or are BVD antigen tested negative and are fully BVD vaccinated – Cattle not fully vaccinated for BVD will not be allowed entry to the auction centre. All animals forward including calves at foot must be D.N.A. Tested. **The D.N.A must either be complete or already in process at the laboratory before you submit your entry for the sale, if you have a pending sample stored at the society, this is not classed as being in process and you MUST request for it to be processed prior to submitting your entry. If the D.N.A. is not in process, the animal will automatically be rejected from the sale.**

Johnes, selling on animals that have been purchased from another herd: When an animal is purchased from a herd with an inferior Johne's disease risk level than the herd to which it is added, the purchased animal retains the risk level of the herd of origin should it be sold on. For example it cannot be sold as risk level 1 if purchased as risk level 2, 3, 4 or 5. Animals that are purchased from a herd with a superior risk level can be sold only at the risk level that applies to the purchasers herd at the time of subsequent sale. For example, an animal purchased as risk level 1 into a risk level 4 herd can only be sold at the risk level that applies to the level 4 receiving herd at the time of subsequent sale.

**All females forward for the show must be halter broken.**

### **Conditions of Entry**

- All animals are accepted for entry subject to passing a standard inspection by Officers appointed by the society, after delivery to the sale venue and prior to the sale.
- All animals must be registered with the society and tagged correctly.
- No reserve prices are acceptable. The vendor or his representative must be present with the auctioneers to accept or refuse the final bid. No animal will be put through the sale ring again.
- Any private sale affected on an animal for which the final bid in Auction was refused must be put through the appointed Auctioneers Accounts.
- All animals eliminated by inspection, will not, if sold privately, be included in the appointed Auctioneers accounts, they will not be sold by auction, and are sold without the Society guarantees only on the Vendors own Cognisance.
- Commission will be at the rate of 5p in the £.
- Please ensure that you have 'ticked' to confirm that your cattle entered in the sale are from a CHeCS BVD accredited herd, or are BVD antigen tested negative and are fully BVD vaccinated – Entries will be returned if not completed correctly. All cattle must be BVD vaccinated as per the vaccine instructions. For cattle which are not from a CHeCS BVD accredited herd they must be BVD antigen tested negative and vaccinated. A veterinary certificate confirming the BVD antigen negative test must accompany the cattle to the sale.
- If you are TB Exempt you must include your APHA letter confirming your exempt status along with the Health declaration form.
- Where showing is part of the Society's Show and Sale, Vendors may elect not to show their animals, but, Vendors who show in the Auction must accept the Judges decision as final. All Charolais females forward must be halter broken and paraded in the show ring.
- All Cattle, including calves at foot must be as a minimum DNA sire verified.
